NOTICE OF RACE

1. RULES

1.1. The Regatta will be governed by the Racing Rules of Sailing 2021 - 2024 (RRS), the special regulations of Yachting Australia and by these Sailing Instructions.

2. ELIGIBILITY

2.1. Entries are invited from all classes of off-the-beach dinghies, trailer-sailers, keelboats, multihulls, sports boats and junior dinghies. Entries may be divided into the following divisions:

- 2.1.1. Division 1: Off the beach monohulls.
- 2.1.2. Division 2: Trailer-sailers and keelboats.
- 2.1.3. Division 3: Off the beach multihulls.
- 2.1.4. Division 4: Sports boats and multihulls.

2.2. The Race Committee reserves the right to subdivide or amalgamate the divisions.

3. ENTRIES

3.1. Eligible boats may enter by:

- 3.1.1. Completing the entry form and emailing to thesecretarytcbyc@gmail.com and paying the entry fees to Tin Can Bay Yacht Club, BSB084952 Account # 868760645 and include the reference: CC and your last name.
- 3.1.2. Completing the entry form and pay by 1000 hours on 27 April 2024 at TCBYC.
- 3.1.3. Completing the entry form and payment and posting to: PO Box 170, Tin Can Bay, QLD 458

4. FEES

- 4.1. Entry fee for the regatta is \$60.00
 - 4.1.1. The fee for one day is \$40.00

6. SAILING INSTRUCTIONS SI

6.1. The sailing instructions will be emailed to entrants prior to the event where an email address is provided. The Sis will be available on the TCBYC website. Limited copies will be available at sign on for all other entrants.

7. RACING AREA

7.1. The event will be conducted within the confines of Snapper Creek and the Tin Can Inlet in the area between Crab Creek to the south and Inskip Point to the north.

8. COURSES

8.1. Courses will be described at the briefing. They may include around the buoys courses and a passage race to Inskip Point/Ida Island.

9. SCORING

9.1. Yachting Victoria Yardsticks and Yachting Australia Class Based Handicap will be used. The Race Committee reserves the right to review and apply an appropriate handicap to any boat.

9.2. One race is required to be completed to constitute the regatta.

9.3. When 4 or fewer races have been completed, a boat's series score will be the total of its race scores (no drops).

10. PRIZES

10.1. Prizes will be awarded as follows:

10.1.1. Outright winner;

10.1.2. First in each division sailed; and

10.1.3. Other prizes will be awarded at the discretion of the organising committee.

11. DISCLAIMER OF LIABILITY

11.1. Competitors participate in the regatta entirely at their own risk. See RRS rule 4, Decision to Race.

11.2. The organizing authority, its officials, sponsors and volunteers will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

12. INSURANCE

12.1. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$5 million per event or the equivalent.

13. TELEVISION AND PHOTOGRAPHER'S RIGHTS

13.1. Competitors give permission for video footage or photographs of themselves or their boat to be published in any media for press, editorial or advertising purposes.
