From 1/9/2016, the TCBYC is a NON-SMOKING venue, covering the whole of the TCBYC lease.

Please read these important notes <u>BEFORE</u> completing your membership form.

This form is a Tax Invoice and is the ONLY current notice of Membership renewal.

**Completing the Membership Form:** Please read the membership form thoroughly before completing it. We ask that you complete ALL sections of the form and understand the declaration before you sign the form.

**Affiliations:** Currently, TCBYC has affiliation agreements with the "Cooloola Dragon Boat Club", "Sailability TCB".and the "Coastal Rowing Club". The mandatory affiliate membership fee for all affiliated clubs is paid per Member. Affiliate clubs will collect affiliate fees on behalf of TCBYC when Membership is paid for the above clubs.

TCBYC Membership Classes (Refer to the TCBYC Rules & By-laws available on the Web site).

**Full Membership** (with voting rights): There are three categories of Full Membership:

- 1. "Competitive Sailing" (Aust. Sailing registered number for Personal Insurance Cover. Please include your DOB for identification perposes).
- 2. "Non-competitive sailing" (May have a boat stored away from YC and only cruises).
- 3. "Hardstand membership" (Keeps a sailing boat in the YC hardstand).

**Junior Membership:** Juniors under <u>18 years</u> when competing will require an <u>AS *Number / Personal Insurance*</u> Cover.

**Social Membership** (no voting rights): Only single Social Membership is available – couples pay two single fees.

**Affiliate Membership:** This is available ONLY to members of affiliated clubs as listed above and gives the equivalent of Social Membership. Unless you wish to be a Full Voting Member of TCBYC, you do not need to take out any other class of Membership if you hold affiliate membership through an affiliated club. If you opt to take out Full Voting Membership with TCBYC, the current affiliation fee (paid) will be deducted from the full member fee. Application to upgrade to full Membership must be made directly to the TCBYC Secretary.

**Visitor Membership:** (May be signed in by a Member), SIGN IN options are suspended .Or applications should be made to the Membership Secretary for the consideration of the Management committee for membership. There is no provision for application for Visitor Membership on the membership form.

**Australian Sailing Sail Pass:** Visitors who wish to crew on a club boat that is racing may apply for a 'Sail Pass' online through Rev. Sport. The Sail Pass fee is \$20. Alternatively, complete a Temporary Membership application/indemnity form and pay an administration fee (ask the Sailing Committee or PRO on the sailing day). If the visitor wishes to join as a Full Racing Member the administration fee is deducted from the membership fee.

**Payment:** Membership payments must be accompanied by a **completed membership** form to ensure the mailing address, email details, phone numbers, etc., are correct to enable the Newsletter and information about other club activities to be sent to members.

Payment of Membership may also be made by cheque or postal order made payable to Tin Can Bay Yacht Club Inc. and posted to **The Secretary**, **Tin Can Bay Yacht Club Inc. PO Box 170, TCB 4580**.

Payments may be made over the bar when open. Till Receipts should be kept as proof of payment. Or receipts issued for cash payments by the Membership Secretary upon receipt of payments.
